

Terms of Use

The following User Agreement ("Agreement") governs the use of the www.InnovationForum.com site ("Innovation Forum"), including without limitation participation in its bulletin boards, forums, chats, and all other areas (except to the extent stated otherwise on a specific page) as provided by Maru Group LLC. ("Service Provider," "we," or "our"), on behalf of Innovation Forum. Please read the terms contained in this Agreement carefully. You can access this Agreement any time at www.InnovationForum.com. **Your use of and/or registration on any aspect of the Innovation Forum will constitute your agreement to comply with these terms.** If you do not agree with these terms, please do not use the Innovation Forum. In addition to reviewing this Agreement, please read our [Privacy Policy](#). Your use of the Innovation Forum constitutes agreement to its terms and conditions as well. The Agreement may be modified from time to time; the date of the most recent revisions will appear on this page, so check back often. I. Registration and Account Creation

1. REGISTRATION INFORMATION:
